## RELEASE AND WAIVER OF LIABILITY

THEREFORE, it is hereby agreed, with such agreement being an integral part of the consideration passing from the student to the Club that THE STUDENT HEREBY FULLY AND WITHOUT RESERVATION AGREES TO FOREVER RELEASE THE CLUB FROM LIABILITY FOR ANY AND ALL CLAIMS FOR INJURIES, DAMAGES, LOSSES OR INDEMNIFICATION RESULTING OR ARISING FROM THE ASSOCIATION OF OR BETWEEN THE CLUB AND THE UNDERSIGNED STUDENT BY THE STUDENT AS A DIRECT OR INDIRECT RESULT OF ATTENDING OR PARTICIPATING IN THE TRAINING EXERCISE OR ANY ACTIVITIES OF THE CLUB RELATED IN THE BROADEST POSSIBLE SENSE TO THE ACTIVITIES OF THE CLUB.
